

# RULES & REGULATIONS



**INITIAL**

1. All participants **MUST BE PHYSICALLY FIT** and agree to comply with these written requirements as well as verbal instructions from our staff, and no participant will be allowed on the course before successfully completing the training session. No headgear of any kind, religious or otherwise will be permitted. \_\_\_\_\_
2. All participants must be **AT LEAST 8 YEARS OLD, OVER 52" TALL, AND WEIGH LESS THAN 250 POUNDS.** Children under the age of 18 may participate provided that a responsible adult is on property for the entire duration of the course. \_\_\_\_\_
3. All participants must be fully ambulatory, and capable of climbing ladders, crossing rope bridges, and hand-braking on zip lines in accordance with instructions. Also, persons who are under the influence of alcohol or drugs, or women who are pregnant, are not allowed to participate. You should also not participate if you suffer from injuries or conditions that could compromise your ability to safely maneuver this physically challenging course. \_\_\_\_\_
4. All participants must wear comfortable, non-restrictive clothing, and **LACE UP SHOES OR BOOTS.** Long hair must be safely secured. You must be able to comfortably and securely wear the safety harness. Participants are not allowed to take unsecured items on the course, and we cannot be responsible for the loss of personal articles. All cell phones, cameras or battery operated devices **ARE NOT PERMITTED.** \_\_\_\_\_
5. As you progress throughout the course, you **WILL REMAIN CONSTANTLY CONNECTED** to the system. As you approach the end of each zip line you **MUST** apply braking force with a gloved hand exactly as you will be instructed to do during the training session. \_\_\_\_\_
6. Only two participants are allowed on a game or obstacle at a time, and only two participants are allowed on a platform at one time. Do not begin a game or obstacle until the person in front of you is over half way though that section. Only one participant at a time is permitted on each zip line. You should maintain a comfortable and safe pace as you advance through the course. Please be respectful to and cooperative with your fellow guests, and allow faster guests to pass you on the platforms when it is convenient. \_\_\_\_\_
7. You **MUST RESPECT ALL SAFETY REQUIREMENTS** and instructions from the staff. Any dangerous behavior, horseplay, and inability or unwillingness to comply with all requirements will result in the termination of your visit. No refunds will be made for these reasons. \_\_\_\_\_
8. If you become afraid or uncertain, or if you do not want to continue for any reason, stop immediately and summon a member of our staff for help. Stay where you are until you can be safely assisted off the course. No refunds will be made for these reasons. \_\_\_\_\_
9. In the event of hazardous weather conditions such as rain, high winds or lightning, the course will be evacuated. You acknowledge and accept the risk of this when you purchase your ticket and agree that no refunds will be made for these reasons. \_\_\_\_\_
10. If either the harness or gloves you are issued are not returned at the conclusion of your visit, you will be charged \$450.00 for each harness, and \$15.00 for each pair of gloves. \_\_\_\_\_
11. Each participant **MUST EXECUTE A WAIVER AND RELEASE OF LIABILITY** acknowledging that they understand and agree to the above rules, they assume the risk of participation, and release Crocodile Crossing and the St. Augustine Alligator Farm from any and all liability in the event of an accident. These requirements are conditions of participation. \_\_\_\_\_

**ST. AUGUSTINE ALLIGATOR FARM AND ZOOLOGICAL PARK**

**WAIVER AND RELEASE OF LIABILITY**

(Read Carefully)

In consideration for the opportunity to experience the Crocodile Crossing adventure course, I acknowledge and agree as follows:

I understand that Crocodile Crossing is a physically challenging obstacle course through the treetop canopy over the St. Augustine Alligator Farm and Zoological Park. I understand that the course consists of rope bridges, ladders and zip lines as high as 50 feet above the ground. It is intended to be physically and mentally challenging. It is not for the faint of heart or people who fear heights.

I fully understand and acknowledge that: (a) the Crocodile Crossing adventure course is potentially dangerous; (b) the Crocodile Crossing adventure course will expose me to the risk of personal injury or death from falls, failure to use equipment properly, equipment malfunction, failure to follow instructions and other foreseeable and unforeseeable causes; and (c) the risk of injury or death may arise from the forces of nature, my own negligence or the negligence of other people, including other participants or St. Augustine Alligator Farm employees.

I hereby assume all risks and dangers, and all responsibility for all injuries, losses and damages I may sustain on or as a result of my participating in the Crocodile Crossing adventure course.

On behalf of myself, my personal representatives and heirs, I hereby voluntarily, release, waive, discharge, hold harmless and indemnify St. Augustine Alligator Farm, Inc., its owners, employees, officers and agents (collectively, the "St. Augustine Alligator Farm") from any and all claims, causes of action, losses and damages for bodily injury, wrongful death, loss of services or otherwise that may arise from my participating in the Crocodile Crossing adventure course, including claims based on the theories, negligence, strict liability or otherwise.

Absolutely no cameras or cell phones on the course or you will be removed from the course. I understand that if I am caught with a cell phone or camera, I will be removed from the course with no refund.

**I HAVE READ THIS WAIVER AND RELEASE AND BY SIGNING IT I CERTIFY THAT I INTEND TO RELIEVE THE ST. AUGUSTINE ALLIGATOR FARM FROM LIABILITY FOR PERSONAL INJURY OR DEATH RESULTING FROM ITS NEGLIGENCE OR FROM ANY OTHER CAUSE.**
